**ATTENTION PERMIT APPLICANT
IMPORTANT – PLEASE READ**

PERMIT REQUIRED

Under Temple City Municipal Code (TCMC) Section 3320, no person shall stop, stand or park a vehicle, all forms of cycles and motorized scooters, and bicycles on any street or in any City or Community Redevelopment Agency owned parking lot between the hours of 2:00 a.m. and 5:00 a.m. of any day without displaying a valid overnight parking permit.

DENIAL

Your application for an overnight parking permit may be denied for one of the following reasons:

1. All parking at residence shall be used for parking drivable vehicles. Storage in parking spaces shall be cause for denial.
2. If there is adequate room to park all vehicles on the premises, the application will be denied.
3. All vehicles at your residence, including those for which an overnight parking permit is not applied for, must be currently registered at the applicant's address.
4. An open and available parking space has been unlawfully converted to a residential dwelling or other non-permitted use.
5. Application for a vehicle used for business purposes may be denied.
6. If there are outstanding unpaid parking citations issued to any vehicle at the residence.
7. The length of the vehicle exceeds 20 feet or the weight of the vehicle exceeds 6,000 pounds.
8. Recreational vehicles, boats, personal watercraft, trailer, all terrain vehicles, off-highway motor cycles, and inoperable vehicles are not eligible for an overnight parking permit.

DISPLAY OF PERMIT

The permit holder shall at all times display the overnight parking permit, as required:

- Annual Permit: All annual overnight parking permits shall be visibly placed on the outside of the rear (back) window in the lower left hand corner (driver's side), or left rear bumper. The permit shall not be effective unless so placed.
- Monthly Permit: All monthly overnight parking permits shall be visibly placed face-up on the driver's side dashboard area of the vehicle, and the permit shall not be effective unless so placed. (3325 TCMC)

CHANGE OF ADDRESS / VEHICLE

The permit holder shall inform the City of any change in his/her residence address. The overnight parking permit will not be valid for a new address in the City, unless the owner applies for a transfer of permit. Permit holders may apply to transfer a permit to another vehicle.

The permit holder shall file an application with the City. The transfer of the permit may be approved or denied as provided in Section 3323 TCMC. The transfer shall not extend the expiration date of the permit. Upon transfer of the permit, the previous permit shall be of no further force and effect and the applicant shall be required to surrender the original permit. If approved by the issuing officer, a new permit will be issued upon payment of a transfer fee and/or replacement fee. (3325 and 3327 TCMC)

FEES

Annual Overnight Parking Permit – The maximum number of annual overnight parking permits shall be limited to two (2) per household. The fee for an annual overnight parking permit shall be prorated quarterly. A senior discount is provided for residents who are 65 years of age or older. All annual overnight parking permits expire at 11:59 p.m. of the 31st day of December of the year for which the permits were issued. (3322, 3323 and 3324 TCMC and Resolution No. 10-4679)

One-time fee, fees apply at time of purchase, all permits expire Dec 31, 2012

Monthly Overnight Parking Permit – Only one (1) monthly overnight parking permit may be issued per residence per month. A maximum of two (2) monthly permits will be issued within a calendar year. The fee for a monthly permit shall be \$35.00. A monthly permit expires at 11:59 p.m. on the 30th day, unless sooner revoked. (3322, 3323 and 3324 TCMC and Resolution No. 10-4679).

Transfer and Replacement – The fee to transfer an annual overnight parking permit to another vehicle shall be \$21.00. The fee for replacement of a lost, surrendered, or destroyed annual overnight parking permit shall be \$21.00. (3326 and 3327 TCMC and Resolution No. 10-4679)

COMPLIANCE WITH LAWS

Issuance of a permit only provides the holder with the privilege of parking on the assigned street overnight and does not except the holder for the motor vehicle from the City's enforcement of all other parking, traffic, and safety laws and requirements of the State of California and the City of Temple City. Conviction or pleading guilty to a parking ticket or citation for a moving violation is grounds for revocation of the overnight parking permit. (3322 and 3325 TCMC)

INSPECTION

An inspection of on-site parking may be required to determine whether the circumstances warrant the issuance of an overnight parking permit. If an inspection or verification of information is required, a conditional permit shall be issued for a period not to exceed thirty (30) days. The fee for a conditional permit shall be \$20.00. (3323 TCMC and Resolution No. 10-4679)
