ABOUT THE CITY OF TEMPLE CITY'S YOUTH SCHOLARSHIP PROGRAM

To make City sponsored youth recreation activities available to all families in the community, the City of Temple City has established a Youth Scholarship Program. The program was developed to encourage participation from families who could not otherwise afford the City's recreation activities' fees.

The scholarship program is available only to youth, younger than 18 years. The scholarship percentage is determined by total household income and the number of persons living at the residence. If a family qualifies as moderate income, fees would be discounted 50%. If a family qualifies as low/extremely low income, fees would be discounted 75%. Scholarships will be awarded only if funds and/or space in the program are available.

The scholarship program applies to all Parks & Recreation activities for youth. Families can use the scholarship for more than one program and for all qualified family members.

To qualify for the program, families must complete an application and provide documentation of household income and residency. Residency documentation includes a copy of a valid driver's license or California ID card and a current utility bill or current dated mail (for **each adult** living at the residence). Income documentation includes three (3) current pay stubs **and** last year's income tax form (for each employed adult).

Applicant must have a total household income within the following guidelines:
