2. PL 22-3558 A request for a time extension for the entitlements of a subdivision project consisting of five attached condominium dwelling units. The entitlements include Tentative Tract Map No. 82843, a site plan review, and a zone variance. The variance was granted for the permeable lot coverage which was required at 40 percent at the time of project approval. The current Zoning Code has no requirement for permeable coverage when a projects will be built on a subterranean parking garage.
